Hall Hire - Terms and Conditions

To ensure the smooth operation of your function, we ask that you read the terms and conditions of this contract. Should you have any questions, please do not hesitate to call the Club for assistance.

Confirmation of your function

- Hall hire charge of \$150 is applicable to all functions.
- A \$200.00 (See Note 1) refundable deposit (subject to no damage being caused to the clubrooms during the event) must be paid at the time of booking.
- Confirmation of a function will only be recognised when a deposit is received. The required deposit must be received by the date specified when the tentative booking is made. If the deposit is not received by the due date, Nerang Soccer Club reserves the right to cancel the reservation for the venue.
- Tentative bookings will be held for a period of 14 days only or at the discretion of Nerang Soccer Club, after which time the booking will be cancelled.
- A deposit is required at the time of confirming all functions. The deposit is to be a minimum of 50% of the estimated amount payable.
- All details must be confirmed no later than 14 days prior to the function or event.
- We require payment in full for the room hire and the amount nominated for beverage expenditure no later than 14 working days prior to the function. Only cash or Visa/Mastercard will be accepted for payments less than 14 days prior to your function.
- Guaranteed minimum numbers are required three working days prior to your function. If final numbers fall 30% or more from the numbers originally booked, management reserve the right to increase the room hire to \$250.00 or an amount specified.
- Where matters beyond the control of Nerang Soccer Club impair or prevent Nerang Soccer Club performing its obligation under the "event order", Nerang Soccer Club management will be released from any liabilities.

During your function

- Clients will be responsible for ensuring the orderly behaviour of their guests and Nerang Soccer Club reserves the right to intervene where it sees fit. (See Note 2)
- Nerang Soccer Club will take all possible care, but accepts no responsibility for damage or loss of property left in the Club prior, during or after functions. The insurance of guest property is the responsibility of the guest. Organisers will be financially responsible for any damage sustained to the Club's property during functions/exhibitions.
- Nerang Soccer Club shall not be liable or in any way responsible for any loss, damage, injury or death which may be sustained or suffered to any property or by any person in or near Nerang Soccer Club by you or your guests.
- No items are to be attached, pinned or glued to the wall or ceiling surface. Poster boards and pin boards may be arranged.

- Function organisers or their guests are not permitted to bring food and beverages to the function without prior written permission of the management.
- Patron Care – Under Qld Liquor Licensing Laws, we have the obligation of Patron Care. At all times, we maintain the right to decline service of alcoholic beverages to Patrons at Private Functions. This is at the discretion of the Nerang Soccer Club supervisor on the day of your function.
- All functions to conclude at 12 midnight, unless prior arrangement has been made. Application for extensions must be made in writing 14 days prior to your function. A labour charge will be incurred.

Surcharges

- Beverage prices are subject to change and are based on our price list at the time of your function.
- A 15% surcharge applies on Sundays and Public Holidays.

Cancellation

The client may cancel the function by written notice to Nerang Soccer Club on the following terms:

- If notice is received 60 days prior to the function/event, the client will be reimbursed the full deposit.
- If notice is received within 30 to 60 days before the function/event, the client will be reimbursed 50% of the deposit.
- If notice is received less than 30 days before the function/event, the client forfeits the deposit in its entirety.
- Please be aware that as of 31st May 2002 new Government Legislation enforces that all catering venues are Strictly No Smoking.

Note 1 A \$450.00 refundable deposit applies for 18-21 parties

Note 2 A security company approved by Nerang Soccer Club must be in attendance for all parties where the majority of patrons are 18-20 years of age.
